Explanation of Modules offered by the Faculty of Law, University of Lampung

Modules/courses offered by the Faculty of the Law University of Lampung consist of modules with a minimum weight of 2 SKS credits (3,2 ECTS Credits) and a maximum weight of 4 SKS credits (6,4 ECTS Credits).

Each Semester Students can only take up to a maximum of 24 SKS Credits (38,4 ECTS Credits)

The Modules offered has 2 levels, which are **University Modules** and **Faculty Modules**.

- **University Modules** are modules that are compulsory for every Study Program that is set by the university.
- **Faculty Modules** are modules that can either be compulsory or can be an interesting choice that is offered uniquely by each faculty, in this case, modules unique to the Faculty of Law.

The Modules offered have 3 statuses, which are **Compulsory Modules**, **Compulsory Interest Modules**, and **Choice of Interest Modules**.

- **Compulsory Modules** are modules that are compulsory to be taken by the Faculty of Law's Students. The compulsory modules are divided from **1st – 5th Semester** and are already set by the Faculty which compulsory modules students will take in each semester. **6th Semester** has several compulsory modules, but this semester, students also can choose their department interest and choose their **choice of interest modules**.
- **Choice of Interest Modules** are modules that students can freely pick and choose starting in the 6th semester. These courses can be taken despite the choice of the department that the student made.
